*Located within NRH, the NCCR offers comprehensive, interdisciplinary, family-centered rehabilitation to children and adolescents from six to eighteen years of age with significant functional limitations as a result of acquired or congenital impairments.*

*The NCCR is located on a self-contained inpatient unit conceived and designed especially to meet the needs of the children and adolescents served and their families. Treatment areas as well as the Educational Resource Center are located on the inpatient unit in a closely monitored, family-centered environment.*

- 9-Bed Pediatric Rehabilitation Unit virtual tour
- Pediatric Play Room virtual tour; this accessible and fun playroom allows occupational and recreational therapists to use toys and games to enhance the potential for an active return to family, school, and community. The room also features televisions and video gaming consoles as well as computers equipped with child-protected Internet access.
